

**Yanceyville Town Council
Meeting Minutes
Tuesday, December 14th, 2021, 7:00pm**

The meeting of the Town Council was held remotely in the Yanceyville Town Council Chambers at the Yanceyville Municipal Services Building and due to COVID-19 the meeting was also conducted electronically through WebEx on Tuesday, December 14th, 2021 at 7:00 pm.

Item 1: Call to Order Reconvene

Pro Tem were then closed. After no further Nominations, the motion was passed with a unanimous vote for Mrs. Odessa D. Gwynn to serve as Mayor Pro Tem.
